- 提出申請後，擬從登記名冊除名的登記雌性狗隻不可再用作任何繁育活動。  
Once the application is made, the enrolled female dog to be removed from the inventory must not be involved in any breeding activity.
- 因「超過5歲或累計已生產4胎或以上」而除名的雌性狗隻，將不可再次列入任何持牌狗隻繁育商的登記雌性狗隻名冊。  
Female dogs that have previously been removed from an Inventory for the reason "Over 5 years old or had 4 or more litters" cannot be enrolled again on the Inventory of any licensed dog breeder.
