To the best of my knowledge, the use of the premises stated in "Section B" in this Form for the carrying on of business for keeping of female dogs for breeding purposes complies with the terms of land-related documents (e.g. the Land Lease, Deed of Mutual Covenant and Rental Agreement).

I understand that I may be liable to prosecution and the licence granted (if any) may be cancelled if I willfully make a false declaration in this Form.

- ¶ 「實用面積」的涵義與第 621 章《一手住宅物業銷售條例》第 8 條相同。如其他涉及申請的處所沒有既定的實用面積，「內部樓面面積」則會被採納為計算面積的基礎。「內部樓面面積」應量度至外牆和 / 或處所與處所之間的分隔牆的內側的樓面表面。「Saleable floor area」in relation to a residential property has the same meaning as assigned to it in Section 8 of the Residential Properties (First-hand Sales) Ordinance (Cap.621). Other premises under application for which the defined saleable area is not readily available shall be assessed on the basis of "internal floor area" meaning the area of the premises measured to the internal face of enclosing external walls and/or separating walls between premises.

1. 你必須年滿 18 歲。You must be 18 years old or above.

3. 牌照從簽發日期計，有效期一年。The licence is valid for ONE year from the date of issuance.
4. 你必須為登記雌性狗隻名冊中所列雌性狗隻的狗主，及其（根據第 421A 章發出的）漁護署狗隻牌照上列明的畜養人。You must be the owner and licensed keeper on the dog licence (issued under Cap.421A) for all the female dogs listed on the Inventory of Enrolled Female Dogs.
5. 不可安排年齡少於 18 個月或大於 74 個月的雌性狗隻生產小狗。Female dogs shall not give birth to puppies when they are under 18 months or over 74 months of age.
6. 參與繁育活動的雌性狗隻必須列入登記雌性狗隻名冊。你不可以擁有多於四隻登記雌性狗隻。請你亦留意在處所內可飼養的狗隻總數取決於處所面積及狗隻體積（見甲類繁育狗隻牌照營業守則）。Female dogs to be involved in breeding activity must be listed on the Inventory of Enrolled Female Dogs. You cannot have more than 4 enrolled female dogs. Please also note the limit for the total number of dogs kept on the premises is based on the area of the premises and size of the dogs (ref. Code of Practice for Dog Breeder (Category A)).
7. 申請中的處所不可註冊為任何其他繁育狗隻牌照或動物售賣商牌照之領有牌照的處所。任何人只能持有或申請一張甲類繁育狗隻牌照。The premises under application must not be registered as the licensed premises of any other Dog Breeder Licence or Animal Trader Licence. A person may only hold or apply for a single Dog Breeder Licence (Category A).
8. 你須附上一份有關申請處所的草圖。You must enclose a sketch of the premises under application.
9. 在牌照申請審批期間，你必須便利本署職員進入申請中的處所，使本署職員可實地視察整個處所。You must facilitate the access of AFCD officers to inspect the whole premises under application as required during the application process.
10. 署長在發出牌照時，可能考慮所有相關因素，包括申請者能否符合牌照條件及營業守則的規定。The Director may take into account all relevant factors, including whether the applicant can conform to the requirements in the Licence Conditions and Code of Practice when issuing a licence.
